**Whereas, Hillsdale County** maintains a county website that is available to the public from any device that may access the internet.


**Therefore**, as soon as administratively possible following the passage of this Resolution, Hillsdale County shall refrain from publishing in a publication of general circulation any meeting minutes, condensed minutes of the Board of Commissioners, meeting notices, available appointments to Boards or Commissions or any other item not specified for printed publication under State or Federal Statute.

**Additionally**, a printed copy of any item or notice posted per this policy on the county website shall be available for viewing in the office of the County Clerk to any member of the public during normal business hours of the County of Hillsdale.

**Furthermore**, the Hillsdale County Board of Commissioners shall place a notice of this policy in a Publication of General Circulation and on the County website as soon as administratively possible following its adoption.


We, your Finance Committee, recommend the following fees be charged by the County Clerk as follows:

| 9. Veteran's I.D.   | \$10.00 |
| 10. Criminal / Civil Searches - \$10.00 per name (flat fee)   |         |
| 11. Ballot Programming Charges –  |         |
| a. \$75.00 Per Precinct   |         |
| b. \$75.00 Per Office   |         |
| c. \$75.00 Per Proposal   |         |
| d. \$20.00 Per Name   |         |
